CHRISTIAN CHAPMAN ART AFFILIATE OPERATING AGREEMENT

This Agreement sets forth the complete terms and conditions that apply to participation in the Christian Chapman Art Affiliate Partner program. As used in this Agreement, "Christian Chapman Art" means Christian Chapman Art C/- PO Box 237 Nobby Beach 4218 QLD Australia and "you" means the applicant. "Christian Chapman Art Affiliate Site" means <http://www.christianchapmanart.com>, the landing website for Christian Chapman Art on the World Wide Web, and "your site" refers to the World Wide Web site that you will link to the Christian Chapman Art affiliate site.

The Christian Chapman Art Affiliate Program is inclusive of all Christian Chapman Art products. As used in this Agreement, "Christian Chapman Art" means Christian Chapman Art C/- PO 237 Nobby Beach 4218 QLD Australia.

1. Becoming a Partner

The Christian Chapman Art Affiliate Program is designed to affiliate with online businesses that are closely aligned with the Art industries. Other industry businesses are welcome to apply, however approval lies solely at the discretion of Christian Chapman Art.

To become a Partner, you must register with Christian Chapman Art by completing the Online Application Form. Your submission of the application constitutes your agreement that you have read and agreed to all of the terms and conditions contained in this Agreement.

If Christian Chapman Art accepts you as an Affiliate Partner, you will receive an email confirmation within ten (10) business days containing your Affiliate Code, user name and password, which will make it possible for you to place links on your site that Christian Chapman Art can track.

We may reject your application if we determine (in our sole discretion) that your site is unsuitable for the Affiliate Partner program. Unsuitable websites include (but not limited) to those that:

- promote sexually explicit or adult orientated materials, including dating services
- promote violence
- promote discrimination based on race, sex, religion, nationality, disability, sexual orientation, or age
- promote illegal services or material, including email or internet spamming and hacker practices
- otherwise violate intellectual property rights including where search terms and methodology conflict with Christian Chapman Art

Due to the nature of our business we are very mindful of the content featured on our affiliate partner websites and try to ensure these partnerships will not offend nor be deemed inappropriate by our customers.

2. Your Obligations

As a Christian Chapman Art Affiliate Partner you agree to actively promote our business on your website through the use of the digital resources available in the Affiliate Resources via [Affiliate Login page](#). This may include (but not limited to) promotional text, business listing or profile, images and banner ads.

Using a unique HTML Affiliate link we forward to you in our confirmation email you will establish links from your website to your affiliate ticket sales page on Christian Chapman Art affiliate website. You agree to actively promote the sales of Christian Chapman Art works through your affiliate link.

If you should not achieve any sales in the period of six consecutive months, your Affiliate membership shall be deactivated. You may apply for the reinstatement of your membership once you are ready to actively sell Christian Chapman Art again. If you should not achieve any sales in the period of six consecutive months after your second application, your Affiliate membership shall be terminated indefinitely.

You will be solely responsible for the development, operation and maintenance of your site as well as for all materials appearing on it. Your responsibilities include without limitation all aspects of the technical operation of your site (including the proper formatting of links so as to permit tracking of sales) and ensuring that the content of your site does not violate or infringe the rights of any third party. Christian Chapman Art disclaims all liability for these matters and you shall indemnify and hold harmless Christian Chapman Art from and against all damages, claims and expenses relating to them. You acknowledge that you shall not compete against keywords specific to Christian Chapman Art and will ensure your affiliate advertising is unique & relative to your site.

GST (Australia Only)

All Christian Chapman Art pieces and merchandise are inclusive of GST. Where your business is not registered or required to be registered for GST, your commission will be determined on the GST exclusive ticket price.

3. Christian Chapman Art Obligations

Christian Chapman Art will handle all customer services, including the taking, processing and fulfilment of orders, for customers who follow links from your site to the Christian Chapman Art Affiliate site. You will receive a commission which will include GST for each successfully completed transaction total, during a session that originated from such a link. (No credit will be given for cancelled artworks.) Your commission payments will be paid directly into the paypal account you nominate in the [application](#).

Commission payments will be made within 14 days of the close of every calendar month. A recipient created invoice will be issued summarising sales and commissions payable for the period. A detailed sales and commission report will be made available online via personal login as part of the program.

4. Term of the Agreement

The term of this Agreement will commence upon Christian Chapman Art's acceptance of your application and will continue until terminated. Subject to clause 5 below, either party may terminate this Agreement at any time by giving at least 5 days written notice, which may be given by email, to the other party. Commission payments to you in respect to customers who may follow links from your site to purchase tickets after this Agreement is terminated, will not be payable.

5. Modification

Christian Chapman Art shall have the right at any time to change or modify the terms and conditions of this Agreement or to impose new conditions. Such changes, modifications or additions shall be effective immediately upon notice thereof, which may be given by any means including by posting on the Christian Chapman Art affiliate site. The absence of notice of termination, which will be effective immediately, by you will constitute your binding acceptance of the change, modification or addition.

6. Relationship of Parties

You and Christian Chapman Art are independent contractors, and nothing in this Agreement shall be deemed to create any partnership, joint venture, agency, franchise, sales representative, or employment relationship between us. You do not have the right to accept any offers on behalf of Christian Chapman Art to act for or bind Christian Chapman Art in any manner and you shall not make any statement, whether or not on your site, to indicate otherwise.

7. Limitation of Liability

In no event will Christian Chapman Art be liable for any indirect, special, or consequential damages arising in connection with this Agreement, your role as a Partner or any item sold under this Agreement.

8. Disclaimers

Other than as required by law, Christian Chapman Art make no express or implied warranties or representations with respect to any item sold pursuant to this Agreement or with respect to the operation of the Christian Chapman Art affiliate site.

9. Content

You acknowledge that the Christian Chapman Art affiliate site contains information, data, graphics and other material protected by copyrights and trademarks and that these rights are valid and protected in all forms, media and technologies existing now or hereinafter developed.
